AS the world grapples with the outbreak of the COVID-19 pandemic and starts dealing with its longer term impacts, Germany and Qatar should reflect on what can be learnt from this crisis and use these opportunities to build a better future, Ambassador of Germany to Qatar HE Dr Claudius Fischbach said on Wednesday.
